This Product Manual shall be used as reference material by all Regional/Branch Offices & licensees to ensure uniformity of practice and transparency in operation of certification under Scheme-I of Bureau of Indian Standards (Conformity Assessment) Regulations, 2018 for various products. The document may also be used by prospective applicants desirous of obtaining BIS certification.

ANNEX - A **Grouping Guidelines**

1. Single Row Deep Groove Ball Bearings as per IS 6455:2026 may be classified as below:

2. Further, Single Row Deep Groove Ball Bearings are grouped as following:

Group	Nominal Size for Bearing Bore Diameter (d)
Group-I	Upto and including 120 mm
Group-II	Above 120 mm to Upto and including 250 mm
Group-III	Above 250 mm to Upto and including 400 mm
Group-IV	All others above 400 mm

3. Based on the above classification and grouping, following grouping guidelines shall be followed for considering Grant of Licence (GoL)/Change in Scope of Licence (CSoL):

- Samples of Single Row Deep Groove Ball Bearings of each type shall be tested separately.
- Samples of Single Row Deep Groove Ball Bearings of each variant shall be tested separately.
- Samples of Ball Bearings for each type of material (for rolling elements, rings and cage) and each tolerance class shall be tested separately.
- Samples of Ball Bearings of any bearing bore diameter from each of the group defined in Sl. No. 3 above , for any of bearing outside diameter and width shall be tested to cover all other bearing bore diameter in that group. However, it shall be ensured that bearing of largest nominal dia for which the firm intends to take the licence is tested. For example, if a manufacturer intends to cover ball bearings upto bearing bore diameter of 500 mm, ball bearing of any bearing bore diameter from Group-I, II & III shall be tested and largest bearing bore diameter (i.e) 500 mm shall be tested to cover the entire range.

4. However, the following relaxation may be considered:

- (i) If sample of Ball Bearings with Flanged Outer Ring is tested, ball bearings without Flanged Outer Ring may also be covered in the scope of licence. If sample of Ball Bearings with Locating Snap Ring is tested, ball bearings without Locating Snap Ring may also be covered in the scope of licence. If sample of Ball Bearings with Locating Snap Ring Grooves is

tested, ball bearings without Locating Snap Ring Grooves may also be covered in the scope of licence. If sample of Ball Bearings with Circlips is tested, ball bearings without Circlips may also be covered in the scope of licence.

- (ii) If sample of Ball Bearings of Two shield (2Z) variant is tested, Two shield (2Z), One shield (Z) and Basic variants may be covered in the scope of licence. If sample of Ball Bearings of Two seals (2RS) variant is tested, Two seals (2RS), One seal (RS) and Basic variants may be covered in the scope of licence. If sample of Ball Bearings of Snap ring (NR) variant is tested, Snap ring (NR), Snap ring groove (N) and Basic variants may be covered in the scope of licence.
- (iii) If sample of Ball Bearings having highest Tolerance class is tested, all other tolerance class may be included in the scope of licence without further testing.

Note: Tolerance class grading - P2 (tolerance class 2) > P4 (tolerance class 4) > P5 (tolerance class 5) > P6 (tolerance class 6) > P0 (tolerance class normal)

- 5. Manufacturers shall declare all the designations of Single Row Deep Groove Ball Bearings they intend to cover in the scope of licence. The Scope of Licence may be restricted based on the Manufacturing and testing capabilities of the Manufacturer.
- 6. During the operation of the Licence, BO shall ensure that all the varieties of Single Row Deep Groove Ball Bearings covered in the Licence are tested in rotation, to the extent possible.

Note:

Manufacturer shall submit the following:

- (a) Hardness requirement, if an upper value is to be specified/ if any special heat treatment is done as per Cl. 10 of IS 6455:2026
- (b) Load Ratings as per Cl. 11 of IS 6455:2026
- (c) Product Noise, as agreed (if any) as per Cl. 12.2 of IS 6455:2026
- (d) Designation for all bearings as per Cl. 14 of IS 6455:2026

ANNEX C

Scheme of Inspection and Testing

1. QUALITY ASSURANCE PLAN

1.1 It is expected that during operation of BIS licence manufacturers will implement a Quality Assurance Plan (QAP) i.e. a plan of regular testing and in-process controls, designed to ensure that the product bearing the Standard Mark conforms to all requirements of the Indian Standard.

1.2 The manufacturers shall define a Quality Assurance Plan (QAP) defining the control unit (i.e. lot/batch etc.), the levels of control (i.e. the frequency and number of samples for conducting the different tests as per the Indian Standard) and declare the arrangement for testing i.e. whether in-house or sub-contracting/ sharing for each applicable test and submit the same to BIS Branch Office for information. The manufacturer shall comply with the QAP and maintain test records in accordance with para 2.1.

1.3 Recommended Levels of Control/ Control Unit:

1.3.1 For the guidance of manufacturers, the recommended definition of control unit is: *entire quantity of Single Row Deep Groove Ball Bearings of same type, same variant and same nominal bearing bore diameter with same tolerance class, manufactured in a day under similar process condition from the same grade of raw materials* shall constitute a control unit.

1.3.2 For the guidance of manufacturers in preparing the Quality Assurance Plan, recommended levels of control are given in [Table 1](#). Manufacturer has the discretion of declaring their own levels of control or accept the levels of control given in this document.

1.3.3 The manufacturer shall ensure inspection and testing as per the Quality Assurance Plan submitted by them on the whole production of the factory which is covered by this plan.

1.4 However, all manufacturers shall ensure compliance of their products to all the requirements of the Indian Standard.

2. ENSURING COMPLIANCE THROUGH TESTING

The manufacturers shall ensure compliance of their products to all the requirements of the Indian Standard for which they may have in-house test facilities. However, there is no obligation to maintain in-house laboratory. Licensee may use alternative arrangements for tests of the production as per the declared QAP. Various alternatives are available for operation of BIS certification as given below and the relevant guidelines for availing such relaxations by the manufacturers, as amended from time to time, are to be referred:

- i) Shared testing resources like common facility,
- ii) Cluster based testing facility,
- iii) Sub-contracting to outside laboratories which may either be:
 - a) BIS recognised/ empanelled laboratories, or
 - b) Any accredited laboratory as per ISO/IEC 17025

2.1 Test Records- The manufacturers shall maintain test records for the tests carried out (either in-house or at a sub-contracted or at shared test facility) to establish conformity of the product to the Standard for operation of licence. For the tests being subcontracted or conducted at a shared test facility, test results issued by the laboratories or test facilities, shall be made available for inspection by BIS.

3. PACKING AND MARKING

The Standard Mark as given in the Schedule of the licence shall be incorporated legibly and indelibly on the packaging of the Single Row Deep Groove Ball Bearings provided always that the Single Row Deep Groove Ball Bearings so marked conforms to each requirement of the specification.

3.1 Packing and Marking of Single Row Deep Groove Ball Bearings shall be done as per Cl. 15 and Cl. 16 of IS 6455:2026.

3.2 **Additional Marking requirements:** The Single Row Deep Groove Ball Bearings shall also be marked with the following additional requirement on its packaging:

a) "For BIS certification details please visit www.bis.gov.in"

4. REJECTION

The production which conforms to the Indian Standard and covered under the scope of this licence shall be marked with the Standard Mark. Disposal of non-conforming product shall be done in such a way so as to ensure that there is no violation of provisions of BIS Act, 2016.
